# **Chair's Report**

#### Welcome to the 3rd Annual General Meeting of the e11bid company.

It seemed only recently I was asked to write the 2010 Chair's report yet, when I pause for a moment, I realise so much has happened over the last 12 months, a year that has had a direct impact on the growth of Leytonstone as a thriving business community. The Olympics is fast approaching, Westfield's Stratford City will shortly open, yet consumer spending is dropping and businesses are finding it harder to find supportive banking.

During our operations, we have taken into account Central and Local Government spending cuts, the VAT increase and the wider economic circumstances to ensure that even in these very difficult times, the e11bid continues to grow.

The top priority for our members is crime. A year has gone by since the installation of our own CCTV system and after few teething problems, our cameras are recording 24/7 and we are liaising on regular basis with the relevant stakeholders to cut crime in our town centre.

Our own main projects - CCTve11 and ShopWatch – have been set up through the establishment of partnerships to make Leytonstone a safer place for trading. Limited financial resources have stopped us from having a 24/7 monitoring but we believe that the cameras and radios are a crucial element to any safe town centre. We are working hard to achieve the 24/7 monitoring of the networks in order to minimise crime in our business community.

Another goal achieved is making Leytonstone a cleaner and more attractive district. Our 4 Star Award from Clean Britain recognised our efforts in turning the BID area into the litter-free zone it is today. Before the establishment of the BID, many of you will remember how the roads were un-swept and badly maintained with black bags littering for hours on the highway. Today our streets are swept constantly throughout the day, refuse bags are picked up within 2 hours. We have new benches, the lamp columns are newly painted with flower baskets and we have over 50 street bins with recycling facilities as well as gum & cigarette disposal bins within the BID area.

Furthermore, regular deep cleansing takes place in the high footfall areas to ensure the area is clean and attractive to encourage customers to shop in our district. I am delighted about the way the Public Realm Department of Waltham Forest is responding to local challenges and I would like to commend them for their support and responsiveness.

The last 6 months our trade waste management and recycling project has taken up most of our time and efforts. The launch of our project 'Cle11n' not only introduced recycling for the first time in the Borough but also is giving the opportunity to the average business to save at least £256 a year compared to the service currently offered by the LA. As waste broker, the e11bid can now help every business to save money on any type of collection service. For many small businesses this project sees the e11bid delivering its true value as it will positively impact your finances.

Last year saw us attracting an extra £128K into the area on top of the yearly business investment which accounts for £55K. This sees us rank as one of the top 5 performing BIDs in the UK according to the 2010 British BIDs survey. Further investment in the area is to be delivered during the next 12 months, thanks to money from TfL and the Olympics will see our BID area improve aesthetically

As we move swiftly into 2011, the renewal of the BID becomes a hot topic and our team will be gauging your opinions on the progress of Leytonstone by conducting surveys so I invite you to collaborate as your feedback is crucial.

To conclude, I would like to take this opportunity to thank the members of the e11bid Management Board for their invaluable contribution towards the operation of the company.

We are all volunteers who take pride in our community and thanks to the e11bid and your contribution our aspirations for the area can become reality.

Set up a partnership with Bywaters in order to provide a tailored trade waste management service to our businesses, to introduce commercial recycling for the first time in the Borough and to ensure businesses can benefit through reduced rates and savings

#### **Terms of Reference**

#### **Statement of Intent**

We were successful in our aim to establish a Business Improvement District in the Leytonstone commercial area. We have accomplished this through localised governance and efficient management, creating a bespoke business environment that enables businesses to flourish.

#### Benefits of the e11bid

- Increased shopper and visitor footfall
- Longer customer visitation
- Reduced crime and theft
- Improved marketing and promotion of our commercial district
- Attractive street environment

#### **Business Decides**

Businesses and all other non-domestic rate paying hereditaments within the designated BID boundary were eligible to vote for a BID in Leytonstone. Businesses had one vote regardless the size of their premises and also have the opportunity to get involved in the governance of our district through regular meetings and events. The five year plan sets out a framework that is transparent and accountable.

#### **The Plan**

Our five year business plan sets out in details the outline of investment, costs and range of services designed to ensure that the business community is fully informed of the e11bid and the processes put in place to ensure its delivery. The e11bid team is committed to bring a professional management structure enabling us to achieve our vision. The team reports directly to the e11bid Management Board.

#### The Investment

Most businesses will pay less than £2 per week. Larger businesses with a rateable value of £50K a year pay less than £10 a week. This value represents minimum investment for maximum return. The e11bid Company spends the investment fund on a range of improvements outlined in its five year plan. The BID alone is expected to generate in excess of £55K of core funding per annum. It is also expected that this fund will be boosted by additional investments of match funding and voluntary contributions.
